Tuition fees (excluding travel costs and excluding accommodation, obligatory lunch at abt. € 30,- per day at the Siena venue has to be paid directly to the Certosa di Pontignano) are € 3.900.- and are due before the beginning of the course.

Applications for the program beginning in October can be submitted immediately. The course takes place as a real European academic event at downtown Düsseldorf at the House of the University and in Tuscany near Siena in the conference center of the University of Siena, the Certosa di Pontignano. The exam module takes place at Düsseldorf University Campus (Juridicum). The tuitition language is English, but during the mock trial also other languages i.e French and German are used esp. for prior art documents to keep the setting a realistic one.

During the mock trial, the company Net Service S.p.A., Bologna, which has also created the real CMS of the UPC, will provide the course with a training server to allow the most realistic scenario possible in the mock trial. Provided that the training server is functioning properly, which is beyond the control of the Heinrich Heine University of Düsseldorf, the mock trial will take place using this system and will aive the participants a practical experience of the proceedings before the UPC!

The European Patent Litigation Certificate - EPLC

The European Patent Litigation Certificate may be issued by the Heinrich-Heine University Düsseldorf acc. to the Decision of the Administrative Comitee of the Unified Patent Court of April 27th 2023 acc. Art. 6 - 8 of the Rules on the European Patent Litigation Certificate and Other Appropriate Qualifications and entitles European Patent Attorneys to act as representatives before the Unified Patent Court (UPC) acc. Art. 48 (2) UPC Agreement, if the course is successfully completed.

- Open for Patent Attorneys as well as Attorneys at Law -

The course is designed for European Patent Attorneys as well as Attorneys-at-Law or jurists with relevant experience in patent law and is intended to encourage their interprofessional cooperation, especially in the context of the integrated mock trial.

Inside its buildings dating back to the Middle Ages, the Certosa di Pontignano comprises the University of Siena's Official Convention Centre, offering services and premises for training seminars and congress activities. In fact, it is famous for being one of the most important academic convention centres in Europe.

The Certosa offers catering facilities in its own restaurant, with obligatory lunch there during the days of the course (to be settled by the respective participant directly with Certosa at abt. 30,- per day) as well as a common evening event during the seminar module (Module 8) of the patent litigation course.

Siena, the medieval student city with its world-famous Campo and Cathedral, can be reached in about 15 minutes by taxi and a good half hour by bus from the Certosa.

The Certosa di Pontignano gives its guests the possibility of choosing from different types of accommodation. Near the Certosa's entrance there are quiet Comfort Rooms. Inside the Main Cloister, right next to the Restaurant, there are the comfortable Classic and Small Rooms.


The Main Cloister also provides access to the proprietary Villa, which hosts the Superior Rooms and the Junior Suite, while the Great Cloister offers apartments.

Airplane/ Train travelers


By car

From Florence Airport, take the tram (direct at the airport entrance abt. every 10 minutes) or a taxi to Florence's main train station (Firenze Santa Maria Novella). From there, there is a direct train connection to Siena main

From there, there is a direct frain connection to Siena main station. It takes about 1 1/2 hours.

From the station in Siena, take a taxi (10 - 15 min) or the bus number S34 to the stop "Pontignano" (abt. 1/2 hour). From the bus stop, the Certosa di Pontignano is just on the other side of the street.

It's also possible to take a taxi or a shuttle transfer service from Florence Airport to the Certosa (abt. € 150). This takes abt. 1 hour. In this case it is recommendable to share a taxi or transfer shuttle with other participants. An alternative to Florence airport are also the Pisa and Bologna airports. Arriving by car the Certosa has a large parking area on the other side of the street.



Arriving from the north (from Florence - Impruneta) take the highway Firenze - Siena (RA3) until you reach "Siena Nord" exit. Take the exit and follow the SR 222 in direction to Castellina. At the junction shortly before Colombia turn right onto SP102 in direction Vagliagli. Follow the SP102 for abt. 5 km until a junction with the indication "Pontignano 1" on the right. Turn right into that small street and follow it for abt. 1 km. You will find the Certosa there on your right and the parking area on the left.

Haus der Universität Düsseldorf - University House -

The Haus der Universität at Schadowplatz 14 is a place of dialogue between science and society in the heart of Düsseldorf. Following extensive renovation, the building was given to Heinrich Heine University for use as an event centre by the van Meeteren Foundation. It has served as an academic conference venue and central forum since 2013 with the aim of anchoring university research/teaching and academic culture at the heart of the city.

Thus, with its downtown atmosphere in one of the the most densely populated regions in Europe (Metropolitan Rhine-Ruhr Region) with approximately 14 million inhabitants and one of the most important patent litigation locations in the world with also a local UPC division the University House with its modern conference technology is also a most advantageous place for the EPLC course.

The Haus der Universität (University House) does not offer its own guest rooms, but in the immediate neighborhood there are a large number of hotels of all categories, up to houses of the highest standards. We refer here to the respective offers on the Internet.

During the days of the event in Düsseldorf, also lunch is not included in the course fee, but left to the participants' own initiative, as there are a huge number of gastronomic options in the immediate vicinity of the University House to suit almost every taste and category. A sufficient break for their enjoyment will be available, of course.

Airplane/ Train travelers

Leaving from the Düsseldorf Airport take the suburban train (S-Bahn) line S11, or the regional lines RE1 and RE5 to Düsseldorf main station. Take the subway (U-Bahn) from there.. The Haus der Universität (University House) is only three subway (U-Bahn) stops away from Düsseldorf main station. Subway lines: U70 (Krefeld), U74 (Meerbusch), U75 (Neuss), U76 (Krefeld), U77 (Am Seestern), U78 (Arena / Messe Nord), U79 (Duisburg) until Heinrich-Heine-Allee station.



By car

The Haus der Universität is situated in the centre of Düsseldorf, in its pedestrian zone at Schadowlplatz 14. Accessibility by car is a little bit difficult, but possible using parking garages that are nearby, but, of course in the city centre quite expensive:
